

Tim Hortons® ROLL UP THE RIM TO WIN® PROMOTION – U.S.A. 2018

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING A PRIZE.
Not open to residents of Rhode Island, Arizona, Hawaii, Florida, Alaska, Puerto Rico.

1. **ELIGIBILITY:** This Promotion is open to legal residents of the United States (U.S.) and the District of Columbia (D.C.) except Rhode Island, Arizona, Hawaii, Florida, Alaska, Puerto Rico and where prohibited by law. Employees, officers and directors of The Tim's National Advertising Program, Inc., Tim Hortons, Inc., (collectively referred to as "Sponsor" or "Tim Hortons"), their parent company, subsidiaries, affiliates, franchisees, Cup suppliers, Cup distributors, Cup carriers, printer(s) of promotion materials, vendors, advertising and promotion agencies involved in the development and execution of this Promotion or any of its materials, and their immediate family members (parents, grandparents, children, siblings or spouse of any of the foregoing), regardless of where they live, or household members (whether related or not) of such employees, officers, directors are not eligible to participate or win a prize.
2. **DATES:** The Promotion will begin on or about February 7, 2018, and is scheduled to end on March 14, 2018, or when Promotion Cup supplies are exhausted, whichever comes last. Write-in requests for a free Promotion Cup must be postmarked by March 14, 2018, and received by March 21, 2018 (unless extended as described below), subject to availability. Promotion Cups that remain in Tim Hortons® restaurants or distribution centers as of March 14, 2018 will be distributed until they are gone or voided. If restaurant distribution of Promotion Cups extends beyond March 14, 2018, as outlined in this paragraph, the Promotion Cups will continue to be distributed for free by mail as outlined in Paragraph 4. Purchasers of multiple cup refillable containers will receive one (1) Cup per container. Each Cup will have a rolled rim. Concealed inside the rim (each, a "RIM") will be a "WIN" or "Please Play Again" message printed on the unrolled RIM (each, a "RIM TAB" and collectively, "RIM TABS"). A "WIN" message will describe the specific prize you may have won, subject to verification. To claim your prize, follow the instructions below. ODDS OF WINNING: The above stated odds calculation is based upon 13,542,336, which is the estimated maximum number of Cups that might be produced for this Promotion (i.e., the sum of the minimum number of Cups to be printed (13,276,800) and the 2% maximum overproduction variance). - Any size brewed coffee beverage (ARV: \$1.64 - \$3.92).

You agree that the requirements of this Disputes section will apply even to disagreements that may have arisen before you accepted these Official Rules. You agree that you will not take any legal action, including filing a lawsuit or demanding arbitration, until 10 business days after you send written notice. If the disagreement stated in the Notice is not resolved to your satisfaction within 10 business days after it is received, and you intend on taking legal action, you agree that you will file a demand for arbitration with the American Arbitration Association (the "Arbitrator"). This arbitration provision limits the ability of you, Sponsor and Administrator to litigate claims in court.

TO THE FULLEST EXTENT PERMITTED BY LAW, THE PARTIES WAIVE ALL RIGHTS TO TRIAL IN ANY ACTION OR PROCEEDING INSTITUTED IN CONNECTION WITH THIS PROMOTION. ANY CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THESE OFFICIAL RULES AND/OR THE PROMOTION SHALL BE SETTLED BY BINDING ARBITRATION IN ACCORDANCE WITH THE COMMERCIAL ARBITRATION RULES OF THE AMERICAN ARBITRATION ASSOCIATION. For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Promotion, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the state and federal courts located in or closest to Miami, Florida.
