

Tim Hortons ROLL UP THE RIM TO WIN® CONTEST - 2012

HOW TO PLAY

1. TO PLAY: Commencing on or about February 20, 2012, guests at participating Tim Hortons locations in Canada may receive one specially marked Tim Hortons 10, 14, 20, or 24 oz hot drink take-out contest cup with the purchase of any corresponding small (10 oz), medium (14 oz), large (20 oz), or extra large (24 oz) hot beverage or any corresponding small (10 oz) or medium (14 oz) Latte, while supplies last. Commencing on or about February 20, 2012, guests at participating Tim Hortons locations in the USA, specifically the states of New York, Ohio, Michigan, West Virginia, Virginia, Kentucky, Maine, Pennsylvania and Indiana (USA) may receive one specially marked Tim Hortons 14, 20, or 24 oz hot drink take-out contest cup with the purchase of any corresponding medium (14 oz), large (20 oz), or extra large (24 oz) hot beverage or any corresponding medium (14 oz) Latte, while supplies last. Revealed inside the rim will be a "WIN" or "Please Play Again" message. A "WIN" message will describe the specific prize available to be won. To claim your prize, refer to instructions which follow, but to be eligible, all prize claims must be received by May 20, 2012 at 11:59 p.m. EDT or store closing, whichever is earlier, the contest closing date. RIM TABS must include the entire message printed under the RIM. Contest Sponsor reserves the right in its sole discretion to reject any prize message that is not presented in its entirety.

*NOTE: Contest Sponsor reserves the right to limit the distribution of contest cups to one cup with the purchase of any hot beverage for any multiple cup refillable container. The guest will receive a cup equivalent in size to the size of the hot beverage or Latte purchased (for example, if the guest purchases a large hot beverage, the guest will receive a large cup, while supplies last). Please note that Lattes are only available in small (10 oz) and medium (14 oz) sizes in both Canada and USA.

Not open to residents of Vermont, Hawaii, Florida, Alaska and where prohibited by law. No mechanical reproductions of requests permitted. All requests must include a postage- paid, self- addressed envelope.

CONTEST CUPS

3. A total of 285,854,400 contest cups have been produced for this contest. These will be available for distribution through April 27, 2012 or while supplies last, whichever occurs first. It is anticipated, based on estimated distribution that contest cups will be distributed within 6 regions as follows:

4. PRIZES AVAILABLE ACROSS NORTH AMERICA

A) Forty (40) 2012 Toyota Camry Hybrids. Approximate retail value in Canada is estimated to be \$35,000 CDN each before any applicable taxes and includes Freight & P.D.I. The approximate retail value in the U.S.A. is estimated to be \$32,400 USD each before any applicable taxes and includes dealer and processing fees.

B) One Hundred (100) Panasonic 3D TV Packages. Panasonic 3D TV Package includes; 55" VIERA 3D TV with VIERA Connect interactive internet service, Four (4) sets of 3D movie glasses (one included with the TV, 3 additional), 3D Blu-ray Disc™ Home Theatre system with iPod Dock, DLNA networking, SD Image Viewer, VIERA Link, 5.1 Audio. Anticipated approximate retail value is estimated to be \$4030.00 CDN each in Canada and \$3680.00 USD each in the U.S., before any applicable taxes.

C) One Thousand (1,000) Coleman Camping Packages. Coleman Camping Package includes; Two (2) sleeping bags, Two (2) foldable chairs, One (1) of each of the following; 8-person tent, Road Trip LXE portable grill, Queen sized air-mattress, 8D LED Lantern, and Propane Coffee maker. Anticipated approximate retail value is estimated to be \$1169.91 CDN each in Canada and \$901.91 USD each in the U.S., before any applicable taxes.

D) Five Thousand (5,000) Panasonic Lumix DMC-TS3 Digital Camera (includes 4GB SD card). Anticipated approximate retail value is estimated to be \$425 CDN each in Canada and \$405 USD each in the U.S., before any applicable taxes.

E) Twenty-five Thousand (25,000) \$100 Tim Card prizes. The cash value of \$100 will be in the currency of the winner's country of residence. Residence shall be based on where a prize claimant ordinarily resides. Country of residence is limited to Canada and the U.S.A. (excluding Vermont, Hawaii, Florida and Alaska). In the event of a dispute, the country of residence shall be determined by Contest Sponsor in its sole discretion based on evidence provided by prize claimant. For the "winning" RIM TABS for food prizes, 75% are Coffee or Latte and 25% are donuts.

Total approximate retail value of all prizes is \$60,422,196 CDN or \$58,583,798 USD.

The retail values set above are based on approximate prize values in Canada and the U.S. at the time of printing of these rules. All estimated retail values do not include applicable goods and services tax, provincial, state or sales and use taxes. Winners are not required to pay such taxes upon receipt of the prize. All other taxes on prizes other than taxes specifically referred to in these rules are the responsibility of the winners. A 1099-MISC will be issued to each U.S. recipient of a prize with a retail value of USD \$600 or more. In order to receive the prize, the winner must provide a completed W-9 form.

6. The regional allocation of the prizes as set out above is an estimate only, based on anticipated cup distribution per region. ODDS OF WINNING

8. At the outset: the overall approximate odds across North America of being eligible to win one of the Forty 2012 Toyota Camry Hybrid vehicles are 1 in 7,146,360; the overall approximate odds of being eligible to win one of the One Hundred Panasonic 3D TV Packages are 1 in 2,858,544; the overall approximate odds of being eligible to win one of One Thousand Coleman Camping Packages are 1 in 285,854; the overall approximate odds of being eligible to win one of Five Thousand Panasonic Digital Cameras are 1 in 57,171; the overall approximate odds of being eligible to win one of Twenty-five Thousand \$100 Tim Cards are 1 in 11,434; the overall approximate odds of being eligible to win a food prize are 1 in 6. In the U.S.A., the estimated odds of being eligible to win one of two 2012 Toyota Camry Hybrid vehicles are 1 in 7,333,200.

To be eligible to claim a prize, prize claimants must have reached the age of majority in their jurisdiction of residence or in the event a person under the age of majority receives an eligible RIM TAB, they are permitted to transfer the RIM TAB to their parent or legal guardian, who will then be the eligible entrant. Without limitation, Contest Sponsor reserves the right to administer a skill-testing question to Canadian residents as it deems appropriate to address discrimination or disability issues.

Prizes may not be exactly as shown in promotional materials. In case of unavailability of any prize, to accommodate for a disability, or for any other reason and in Contest Sponsor's sole discretion, Contest Sponsor reserves the right to substitute a prize for a prize of equal or greater value.

17. Each winner will be notified by and will receive their prize from Tim Hortons Advertising and Promotion Fund (Canada) Inc. / The Tim's National Advertising Program, Inc. All prize claims become the property of the Contest Sponsor and no correspondence will be entered into except with potential winners. By participating in this contest, contest winners are deemed to have consented to the disclosure of their personal information to prize suppliers for the limited purpose of delivery of prizes and registration for warranty purposes.

18. By claiming a prize, prize claimants consent to the use of their name and/or photograph, and/or place of residence, without compensation, in any publicity carried out by the Contest Sponsor.

19. Contest Sponsor is not responsible for lost, late, illegible, incomplete, mutilated, misdirected or postage-due rule requests, cup requests, or prize claims.
